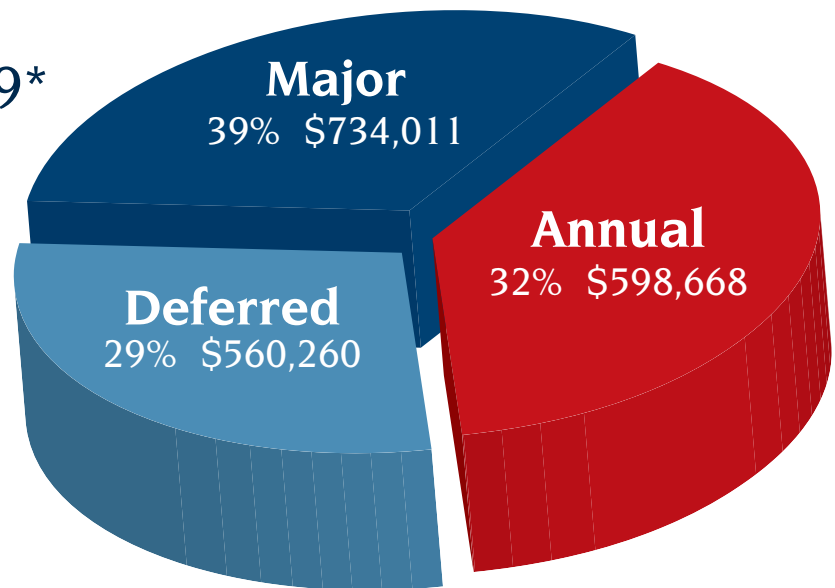

Lend-A-Hand

The Baxter Regional Hospital Foundation hosts several events throughout the year with the theme "Lend-A-Hand, Touch A Life". This is done to enlist the community's help to financially support the Mruk Family Education Center on Aging, Peitz Cancer Support House, Reppell Diabetes Learning Center and Schliemann Center for Women's Health Education.

This year's Lend-a-Hand campaign in November included **a large gift from the Baxter Regional Medical Center Auxiliary**, numerous business contributions and a large mailing for Giving Tuesday. In February, the **4th Annual Masquerade Ball** was held. The attendees came dressed in their finest gowns and suits with a wide array of beautiful masks. The evening began with a social hour, red carpet photos, silent auction and photo booth, followed by

BRMC Employee Fund Drive In 2018, our remarkable employees once again rose to the occasion with 83% contributing (1,243 staff members), pledging \$165,491 during the 2018 Employee Fund Drive.

The national average for hospital employees to participate in employee fund drives is 25%. Many of our areas funded (some of which are solely funded by our employees) include the Employee Crisis Fund, Friends Fund, Employee Children and Grandchildren Scholarship Fund, Mountain Home Christian Clinic, Hospice House and the BRMC Community Health Education and Support Houses. In the 18 years of the Employee Fund Drive, BRMC staff members have raised over \$2 Million Dollars!

Working with your physician and other members of your health care team, the Certified Diabetes Educators at the Reppell Diabetes Learning Center will provide you with the tools, equipment, and support needed to manage your diabetes.

Approximately 10% of Americans are diagnosed with diabetes and another 84 million over the age of 18 have pre-diabetes. Type 1, Type 2, Pre-Diabetes and Gestational Diabetes affect more people every year. With proper education and management, diabetes can be well controlled and complications can be avoided.

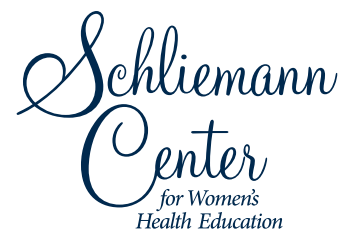

A Year of Many Blessings

What a blessing it is to live in a community of givers. Please allow us to reflect on and share how your community hospital - Baxter Regional Medical Center (BRMC) - was impacted by your gifts of support in 2018.

In 2017, the Hospital Foundation kicked off a campaign to raise \$1 million to renovate the Acute Inpatient Rehabilitation Unit at BRMC. In early 2018, we were able to reach that goal thanks to so many generous donors.

Work began in the fall of 2018 to transform this unit. What an amazing transition it has been. We were able to celebrate all the donors of this campaign on February 7, 2019 and show off the beautiful new unit. With many improvements for both patients and the staff caring for them, this unit is running stronger than ever and looking forward to many more years of helping patients turn hurt into hope.

Have you ever owned a vehicle that had covered almost 500,000 miles in its lifetime? Well, that was the dilemma faced by the BRMC Emergency Medical Services team last year. Two BRMC Ambulances had accumulated almost 1 million miles between them and were in desperate need of replacing. One of BRMC's mottos is to deliver "outstanding patient care to every patient, every time." These old ambulances were making that difficult due to the frequent engine breakdowns. The support of our wonderful community was there to assist BRMC yet again. **The Hospital Foundation Save-A-Life campaign was able to raise over \$150,000 in community support to help BRMC purchase two new ambulances.** These ambulances will soon be on the road saving lives and assisting those in need. Thank you Community!!

We were also blessed to receive a grant from the Ernest and Anna Ritter Family Endowment to fund the crucial upgrade of the BRMC

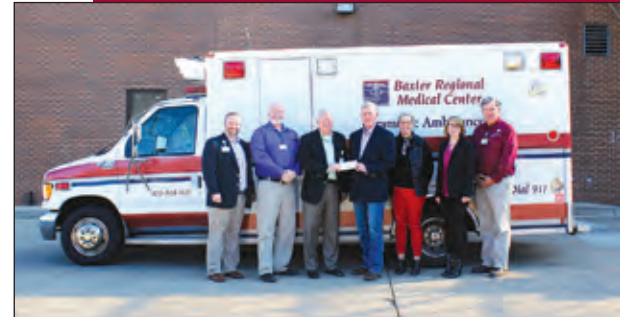
Emergency Medical Services (EMS) ambulance radios. The current system utilized the aging VHF/UHF radio signal requiring ambulance staff to monitor the radio frequency closely or risk losing signal. **With the grant from the Ritter Family, BRMC has begun the process of upgrading its radios to a system that utilizes a more reliable digital signal.** Most importantly, this will upgrade will enhance care for BRMC patients.

Our look back at 2018 could not be complete without including the support that has been provided by the Baxter Regional Auxiliary. What is a Deferred Gift?

Deferred Gifts are the Future of BRMC

A deferred gift is a gift that is made in the future, usually when the donor has passed away. There are a variety of ways to make a deferred gift:

- **Bequest** in your will or trust a gift of a specific dollar amount, percentage of what is left after providing for relatives, or even a particular asset. If you already have a will, you may add a bequest through a simple codicil or amendment naming the Baxter Regional Hospital Foundation.
- **Make the Hospital Foundation the beneficiary of a Retirement Plan.** This can simplify matters for your loved ones by directing all or a portion of what remains in your retirement accounts to charity and leaving more tax-favored assets to your heirs. You may designate the Hospital Foundation as a beneficiary of your IRA without changing your will.
- **Name the Hospital Foundation as beneficiary of life insurance policies** without changing your will or estate plans. These policies can often be a good choice to fund charitable gifts as your financial and family circumstances change over the years.

As you can see, deferred giving can provide a great way for donors to support the charitable causes they love. These gifts can also provide valuable tax benefits for you and your
